#### 1. BACKGROUND OF THE WORK:

#### 2. SCOPE OF WORK:

The Directorate of KBK & OML wishes to avail the services of a Company/Firm/Agency/ Proprietor (sole/joint) to provide high-quality photography and video coverage services, including editing and production of short films/reels for social media, which shall broadly include thefollowing jobs:

- a) Carrying out commercial photography with complete professional equipment such as Camera, Lenses, Filters, Colour Correction Card, Flash, Reflectors, Tripods, StudioBackdrop, Monitors, Fill In lights, umbrella lights, light kits etc.
- b) High-quality video editing and production work for short clips and social media posts/reels, which shall involve:
  - i. Video planning and story boarding
  - ii. Creating video footage, controlling lighting, sound, and other technical aspects
  - iii. Video editing
  - iv. Colour enhancement and manipulation.
  - v. Audio editing and mixing and using voice over
  - vi. Effects and animation (if necessary)
- c) The production material (photographs & video) shall be delivered by the selected agency either online (cloud link) or offline (Portable SSD / SATA hard drive/USB pen drive & high-quality hardbound Photo Album) as per requirement.

#### 3. GENERAL TERMS & CONDITIONS:

- a) All the columns in the Technical Bid format need to be filled by the bidders and submitted by superscribing "Technical bid for ...."
- b) The Technical Bid should not contain any indication of the price. In case any indication of the price quoted is included in the Technical Bid, such Bids shall be rejected. No correspondence will be entertained in this regard.
- c) All material, photographs, video footage and all such information etc generated during assignments will be the property of the Directorate of KBK & OMLand and will have sole rights for its use in future and will be copyright protected.
- **d)** The expenditure on travelling, accommodation, any other allowance, etc, incurred during the photography/video coverage and production assignments would be borne exclusively by the Bidder / Agency.
- e) The Directorate of KBK & OML reserves the right:
  - i) To reject any / all applications without assigning any reasons thereof.
  - ii) To relax or waive any of the conditions stipulated in this document as deemed necessary in the best interest of the ITPO without assigning any reasons thereof.
  - iii) To include any other item in the scope of work at any time after consultation with prospective agencies or otherwise.

#### 4. ELIGIBILITY CRITERIA:

- a) The bidder should be a photography agency/ production house/ commercial photographer/ electronic media agency/ freelancer with a minimum of 5 years of having provided photography & related services on a hire basis for government departments/private companies etc. Copies of work orders / Bills should be submitted as a proof of receipt of payment in support of these events.
- b) The bidder should have its production, designing and video and image editing setup/equipment necessary for carrying out the work.

c) The Bidder will submit relevant documents included in the Tender the effect that the information submitted by him is correct and he will abide by the decision of competent authority of Directorate of KBK & OML regarding the tender.

- d) The bidder should have not been de-registered/blacklisted, previously by any government organization. A Certificate to this effect to be submitted on the letterhead of the firm/agency.
- e) The bidder should have a PAN Number (mandatory) and GST Registration (if applicable).
