

The function of the Expert Committee will be as follows (TOR) –


1. Assessing the project proposal/s – its viability, authenticity & relevance.
2. After evaluating the project proposal/s, recommending to the Directorate of Kokborok & Other Minority Languages the name/title of the project proposal/s that can be accepted for final registration & for providing grants.
3. Evaluating the progress of the project/s (MRP/s) after every six month from the date of final registration of the project/s.
4. Giving valuable suggestions & inputs to the Principal Investigator on the research work (MRP), if so felt necessary.
5. Evaluating the project/s (MRP/s) after its completion.
6. After completion of the project (MRP), recommending to the Directorate of Kokborok & Other Minority Languages the name/title of the project/s (MRP/s) that can be accepted for final submission & thereof.
